Lau-Smith led a robust discussion at the Board of Managers request regarding the possibility of making school site athletic directors at the high and middle schools full time. The group shared some of the unique needs of

each school site and along with various obstacles that would need to be discussed. It was shared with the group that athletics would draft position descriptions with minimum qualifications and evaluation tools for athletic director and coaching positions.

SFUSD Assistant Director of Athletics Edwin Weathersby II opened a discussion with the Board of Managers regarding security for the remainder of the school year at Athletic Contests. Weathersby reminded the Board of Managers of an email previously sent by him urging Principals to have their T-10 personnel sign up to work security at Athletic Contests. Weathersby also noted that the provision of a T-10 being restricted to games only involving the school they work for has been waived by the Athletics Office. Barksdale noted that the above link of School Site Security included Black Bear and T-10 scheduling, as well as a column for how many more security personnel is ideally needed for each corresponding contest that is viewable for all SFUSD Principals.
